The durable and versatile **Jeranimo** won 8 Grade I and II Stakes on and off the turf. **Jeranimo** ran world class times winning the 1 1/8 mile San Gabriel 3 times in as fast as 1:46.5; 1 1/8 mile Eddie Read Handicap in 1:45.8; Shoemaker Mile in 1:33.9; 1 1/16 mile Seabiscuit Handicap in 1:40.8; Oak Tree Mile in 1:32.6; and 1 1/8 mile Strub Stakes in 1:47.8. **Jeranimo** raced in 3 Breeders' Cup races - the 2011 and 2012 Breeders' Cup Turf Mile and the 2013 Breeders' Cup Turf Sprint.

**Jeranimo** is a stallion with a world-class race record that will pass on versatility, soundness, and longevity with an electrifying turn of foot. He is being offered at \$5,000, live foal guarantee.




## JERANIMO BREEDING AGREEMENT

This agreement is made between Jeranimo Partners, owner of Jeranimo (2006 bay colt by Congaree out of Jera), and the below-identified Owner or Manager of a thoroughbred farm in California. The parties agree that Owner or Managers shall have the opportunity to breed the mare \_\_\_\_\_ to Jeranimo in 2015, subject to the following terms and conditions.

1. Owner or Manager shall pay \$500.00 to Tommy Town Thoroughbreds before breeding.
2. If Pregnant from the 2015 breeding with Jeranimo, the mare must foal in California.
3. Owner or Manager shall register the foal from the 2015 breeding with Jeranimo as a California Bred and pay for all registration fees.
4. Owner or Manager shall register Jeranimo Partners as a 50% breeder of the foal resulting from the 2015 breeding with Jeranimo.
5. Owner or Manager shall nominate the foal resulting from the 2015 breeding with Jeranimo to the Golden State Series and pay all nomination fees.
6. The Jeranimo partners shall have no ownership interest or any other interest in the foal arising from the 2015 breeding with Jeranimo except for their interest as a 50% breeder of the foal, entitling Jeranimo partners to 50% of all breeder awards.
7. If the 2015 breeding does not result in a live foal, Owner or Manager shall be entitled to breed the above-identified mare to Jeranimo in 2016 on the same terms and conditions set forth herein, except the \$500.00 payment to Tommy Town Thoroughbreds shall be waived.
